on the crisis in Bosnia-Herzegovina and the declarations of NATO

The European Parliament.

Having regard to:

- A. the desperate condition of the people in Bosnia-Herzegovina and their belief that they have been betrayed by the failure to ensure respect of the minimum standards of international law;
- B. the dissatisfaction of the UNPROFOR troops and their commanders, with the weakness of their mandate and the lack of the strength needed for the carrying out of the UN decisions;
- C. the continuing attacks against the civilian population and the frequent interruptions of the supply of humanitarian aid:
- D. the request of the French Government for US military assistance to stop the violence;
- E. the reluctance of EU Member States to provide troops in spite of solemn promises;
- F. the fact that a large proportion of the population of Bosnia-Herzegovina is still maintaining a multi-ethnic society;
- G. the isolation by blockade and siege of towns and regions;
- H. the mandate, the strategy and the utter lack of results achieved by the EU negotiator, Lord Owen who, although Bosnia-Herzegovina is a member of the United Nations, strive constantly to divide it on ethnic grounds;
- I. the declarations of the NATO Summit;

Demands:

- troops to ensure, by their active intervention, the safety of all "safe-areas" as promised by the Council and the Member States;
- the recognition and protection of the right of the legal government of Bosnia-Herzegovin to a viable state;
- the opening of supply routes and the airport to Tuzla, which is the biggest area where the Bosnians still maintain a multi-ethnic civilian government;

- 4. active assistance to all those throughout former Yugoslavia, who support human rights democracy and dialogue against chauvinism and ethnic cleansing;
- 5. the elimination of artillery positions from which ceasefires are broken;
- 6. the elimination of sniper activities;

- 7. the determination to enforce peace as there is no peace to keep:
- 8. active diplomacy and pressure on Croatia in order to end Croatian attacks on Bosnia-Herzegovina and to restore good relations between these two countries:
- 9. the nomination of a new negotiator for the EU with an adequate mandate to carry out and a new strategy for doing so:
- 10. the rigorous maintenance of the sanctions against the Belgrade regime until all Serb aggression against Bosnia-Herzegovina is ended;
- 11. that political, operational and financial support for the International Tribunal for War Crimes in former Yugoslavia be part of the Common Action Programme of the European Union:

12. Instructs its President to forward this resolution to the Commission, the Council, the Secretary-Generals of the UN, NATO and the WEU as well as the Governments of Bosnia-Herzegovina, Croatia and Serbia.
